

Sir,

Please refer to your letter noted above. The Chairman, Bar Council of India now grants provisional approval of affiliation to Kohima Law College, Kohima and Mokokchung^{Law College} as these Colleges were earlier affiliated to NEHU, Shillong and were included in the list of Law Colleges approved by the Bar Council of India. Since the jurisdiction of the above Law Colleges has changed and came under a new University viz. Nagaland University, it is necessary to have the inspection carried out before granting approval of affiliation. However in view of the special circumstances prevailing in the North East, the Bar Council of India now grants approval of affiliation to the above two Law Colleges on the temporary basis for the time being. The Bar Council of India will in the meantime inspect the Colleges. The Bar Council of India has now received inspection fee from Kohima Law College, Kohima but there is no response from the Mokokchung Law College, Mokokchung. You are requested to ask the College to deposit the inspection fee at once.

As regards Dimapur Law College, Dimapur, it may be noted that this College is not yet approved by the Bar Council of India at any stage and therefore it has no approval of affiliation of the Bar Council of India. This is for your information.
